Illinois Gov. Pat Quinn vetoed a modernization bill that would have upgraded the infrastructure of Ameren and ComEd--but at what critics say was too high a cost in rate hikes and diminished oversight.

In a Chicago news conference announcing the veto, Quinn called the bill "a dream come true" for the utilities, but "a nightmare for the consumers of Illinois."

The bill, SB1652, would have spurred a 10-year "Smart Grid" utility upgrade that would have included "smart meter" technology to show consumers the price of their electricity use on an hourly basis, helping those consumers adjust their usage.

But critics, including Illinois Attorney General Lisa Madigan, say the bill was geared more toward guaranteed profit hikes for the utilities than longterm savings for consumers. It would have meant an average 9 percent rate hike for utility customers, and contained language that Madigan and others say would lead to loosened oversight of the utilities.

"The fight is long from over," noted Madigan, who attended the veto ceremony.

The utility industry is expected to seek a veto override when the Legislature returns to Springfield next month. The original legislation didn't pass with a veto-proof majority, but the utilities are among the more powerful lobbies in Springfield and are likely to push hard for those extra votes.

A statement from ComEd shortly after the veto makes it clear the veto-override effort has already begun: "In the coming weeks, we will work to show how this legislation provides a diverse array of important benefits to Illinois. . . . We look forward to working with members of the Assembly to help make modernization and economic growth a reality in Illinois."
